IOU and UTB are hereinafter individually referred to as "Party" and collectively referred to as, "the Parties".

NOW, THEREFORE, the Parties agree as follows:

Article 1: PURPOSE

The purpose of this Memorandum of Understanding (MoU) is to establish a cooperation framework between the Parties.

Article 2: SCOPE

The scope of this MoU covers the areas of Teaching, Learning Enhancement (TLE), Undergraduate and Postgraduate Studies (PGS) and Research for the mutual interest of the Parties.

Article 3: RESPONSIBILITIES OF THE PARTIES

Both Parties agreed to partner in the following:

- (1) Sharing experience in e-learning & teaching
- (2) Providing exchange internship, research hosting and placement opportunities for qualified students of the two universities
- (3) Exchange materials in education, research, publications, and academic programming; and other professional development activities
- (4) Exchange in academic staff
- (5) Partnering in establishing an IOU learning center at the UTB in Rwanda

- (6) Partnering in establishing a new IOU examination center at the UTB in Rwanda
- (7) Collaborating in training and research in areas of mutual interest
- (8) Facilitating and coordinating joint research programs and curriculum development;
- (9) Organizing joint conferences, workshops, and symposia.
- (10) Partnering in recommending scholarship beneficiaries at each of the parties

Article 4: TERMS AND TERMINATION

This MoU shall come into force on the date of signature by the Parties and continue in force for a period of five (5) years. Termination may occur by either party upon thirty (30) days written notice. However, it may be amended or modified only in written agreement signed by each Party any time or after five (5) years.

Article 5: CONFIDENTIAL INFORMATION

The Parties hereby agree that any information relating to (A) affairs received by or made available by one party (the "disclosing Party") to the other Party (the "receiving Party") shall be regarded by the receiving party as confidential and shall not be disclosed to the third parties, or used for any purpose other than that for which it was disclosed, without the disclosing Party's prior written consent.

Article 6: DISPUTE SETTLEMENT

The parties shall amicably and by mutual understanding settle any problems, disputes or differences arising from or in connection with this MoU with their duly appointed representatives within a reasonable period after either party giving notice in writing to the other party of such dispute.

Article 7: NOTICES

All notices, deliveries and other communications pursuant to this MoU shall be in writing and shall be made by personal delivery or by nationally recognized courier to the other party at the address set forth below. Any notice to a party may also be given electronically so long as a hard copy of the notice is also delivered to the party where possible.
