THE RISE OF ISLAMIC FINANCE Actually, the fault line in the international financial system results from the lack of adequate market discipline due to the absence of explicit risksharing. It is this fault line which makes it possible for the financier to lend excessively and also to move funds rapidly from place to place at the slightest change in the economic environment. A high degree of volatility thus gets injected into interest rates and asset prices. This generates uncertainty in the investment market, which in turn discourages capital formation and leads to the misallocation of resources. There may be nothing basically wrong with a reasonable amount of short-term debt used for financing the purchase and sale of real goods and services by households, firms, and governments. However, an excess of it tends to get diverted to unproductive uses as well as speculation in the foreign exchange, stock, and property markets. Jean-Claude Richet, former President of the European Central Bank, has rightly pointed out that: "A bubble is more likely to develop when investors can leverage their positions by investing borrowed funds."

### What's the Right Solution?

safer.

Strict compliance with regulations and supervision should be complemented by a shift towards more discipline in the financial system. This involves making both investment depositors and banks share business risks. Simply bailing out banks is not sufficient. It's important to motivate depositors to be cautious in choosing their bank and encourage bank management to be prudent in their loans and investments. Bank managers, who can better evaluate asset quality, would be motivated by risk-sharing to make decisions benefiting both banks and depositors. Therefore, reinforcing bank regulations and supervision with self-discipline is necessary. This can be achieved by increasing reliance on equity rather than debt, as advocated by major religions, and confining credit to financing real goods and services with some risk-sharing by the lender.

The International Monetary Fund (IMF) supports equity financing,

### The Global Financial Crisis Spares None. How do we Escape it?

### **The Financial Crises**

The efficiency argument in favor of the conventional interest-based system of financial intermediation has been substantially weakened by the crises it has experienced over the last few decades. There is not a single geographical area or major country that has been spared the effects of these crises. Hence, there is an uneasy feeling that "something is wrong with the global financial system." This has led to a call for comprehensive reform of the financial system to help prevent the outbreak and spread of financial crises or, at least, minimize their frequency and severity. The needed reform has come to be labeled "the new architecture."

### Inadequate Market Discipline: Is this the Root Cause?

The primary cause, in our view, is the inadequate market discipline in the conventional financial system. Instead of making the depositors and the bankers share in the risks of business, it assures them of the repayment of their deposits or loans with interest. The ability of the market to impose the required discipline thus gets impaired, leading to an unhealthy expansion in the overall volume of credit, excessive leverage, and living beyond means. This tendency of the system gets further reinforced by the bias of the tax system in favor of debt-financing; dividends are subject to taxation while interest payments are allowed as a taxdeductible expense. viewing it as a safer way to finance development compared to shortterm borrowing. While investment depositors might be risk-averse, banks can invest their funds in less risky assets and build loss-offsetting reserves to protect depositors from losses. This approach would make banks more effective in risk management and the banking system

Greater reliance on equity financing is also supported in mainstream economics. Harvard Professor of Economics, Rogoff, suggests that equity lending and direct investment should play a bigger role. He believes that a better balance between debt and equity would enhance risksharing and reduce financial crises. Aligning debt with the purchase of real goods and services, as Islamic teachings require, would further reduce financial market instability by curbing excessive credit expansion for speculation.

# **Islamic Fintech** What's the Buzz?

he projected market size for Islamic Fintech is expected to reach \$179 billion by 2026, growing rapidly at the rate of 17.9%, in contrast to the global Fintech industry, which is anticipated to grow at 13.5%.

Fintech is short for financial technology and often considered a new term, but it actually has deep historical roots. This concept dates back centuries, indicating its lasting significance. It refers to the integration of technological advancements into financial services to improve and automate them. Over time, technological advances have consistently altered how we manage finance and money. It started with ancient records of government finances, which led to the invention of money for trade, then to mobile banking and now to cryptocurrency. This highlights a rich and lengthy history of Fintech, underlining how technology has always been a critical part of financial systems and transactions.

In Islamic finance, Fintech marks a significant advancement. Islamic Fintech integrates technology and finance in accordance with Islamic rules, principles, and ethos. All products and services in this domain must follow Sharia principles, demonstrating a commitment to

finance.

This sector aims to create new technology-based business models that support social, financial, environmental, and economic goals. These objectives include enhancing the efficiency of Islamic financial services and broadening benefits such as social justice, financial inclusion, and poverty reduction. Islamic Fintech expands the scope of traditional Islamic finance through emerging technologies in the field, making the services more accessible and cost-effective. This, in turn, creates more opportunities for Shariahcompliant financing and investments.

Islamic Fintech platforms are increasingly utilizing advanced technologies such as artificial intelligence, blockchain, big data, extensive cloud computing, and Internet of Things (IoT) devices. These technologies are enhancing the delivery of Islamic financial services, making them more advanced and transparent.

The 2022 Global Islamic Fintech Report offers a detailed look into the growing Islamic Fintech sector, identifying 375 Fintech entities worldwide.

In 2021, the Islamic Fintech transaction volume in countries of the Organisation of Islamic Cooperation (OIC) obtained \$79 billion, making up 0.8% of global Fintech transactions, according to a report. The expected increase of Islamic Fintech to \$179 billion by 2026 shows a strong Compound Annual Growth Rate (CAGR) of 17.9%, higher than the 13.5% CAGR forecasted for the global Fintech market.

Countries like Saudi Arabia, Iran, the United Arab Emirates, Malaysia, and Indonesia are leading in transaction volumes in this area. Currently, eleven countries have an Islamic Fintech market of over \$1 billion, greater than the preceding year, with Qatar as the newest addition. Predictions for 2026 indicate that four more countries will reach a market size of over \$1 billion.

The field of Islamic Fintech is constantly progressing, introducing new ways of merging financial services and technology throughout a business' growth, all in line with Shariah principles. This allows established market players to update old processes, business models, and systems, resulting in significant improvements in the customer experience.

### The Revival of Trade Within the Islamic World

rade within the Islamic world has emerged as a critical issue for Muslim nations due to the state of their economies, despite their interactions with the West and the adoption of policies enforced by more developed nations. The relationship between Less Developed Countries (LDCs) and Developed Countries (DCs), or the world powers, has often been detrimental and particularly disadvantageous to Muslim countries.

It has been roughly 50 to 60 years since former colonies became politically independent. However, this independence has not led to economic freedom. There seems to be a return of colonial-like control, achieving what previous colonial and imperial efforts did not accomplish for the colonizing countries.

awaken to the current realities. There are efforts to boost trade within the Organisation of Islamic Cooperation (OIC) to 25% of total trade by 2025. Trade among OIC member states is deeply rooted in their ideological and historical backgrounds. Geographically, most of these countries are neighbors, holding key strategic positions along major global routes.

The 14th Islamic Summit Conference in 2019 highlighted this resurgence among OIC countries, marked by an increase in trade to 20.33% in 2017. To reach this goal, OIC nations agreed to augment the capital of the Islamic Development Bank, fostering infrastructure and social development.

In 2005, trade within the Islamic world totaled \$271 billion, just 15.5% of these countries' total exports. This figure fluctuated until 2014, peaking at \$802 billion (19% of all exports). In 2015, the percentage slightly rose to 20%, though the value dropped to \$694 billion due to declining commodity prices globally. Muslim countries span a vast region from Northwest Africa, like Morocco, to Southeast Asia, like Indonesia.

These countries extend from the Atlantic to the Pacific Ocean, covering the Mediterranean and Indian Oceans. They control important trade routes like Gibraltar, Bosporus, Hormuz, Malacca, and the Suez Canal, highlighting their strategic importance.

Intra-Ummatic trade is indispensable to prevent further deterioration of the state of the Muslim Ummah, whereby Muslim countries have become irrelevant in decision-making on the global front. It can serve as a path to unity, economic growth, and consequently political strength. No single Muslim nation can protect itself from the intrigues of developed countries on the international front. However, unity can be a comprehensive means of solving economic, political, and security issues.

Through this system of trade among OIC members, it is possible to see an Islamic globalization setting in. This would create a system where Muslim nations regain their global importance, and Muslim populations are afforded the protection and human dignity they deserve.

# "This is Just the Start"

### Gambia Tops Fall 2023 Enrollments

he International Open University (IOU) has become a key educational institution in The Gambia, attracting people from both the public and private sectors. The university has achieved remarkable growth, evidenced by the increasing number of Gambian students enrolling. This surge in popularity is rapid and widespread. As Fatou Jobe, a student, observed with a wide smile, "Mr. Gaye, the crowd here is big, but this is just the start. Next semester, it will be even bigger. More and more people are learning about IOU."

This increase in enrollments can be attributed to various factors such as affordability, accessibility, and flexibility. IOU's tuition fees are relatively low, making education more accessible. Additionally, many of IOU's programs allow students to work while they study. For example, graduates from Gambia College can join a program at IOU to earn a Bachelor of Education degree in two years, saving them time, money, and effort.

The support from Microbiology Research Centre-Holland (MRC-Holland), a foundation focused on advancing education in developing countries and sponsoring many students and providing them with learning equipment, is a testament to this commitment. # IMAS Expands Across Nigeria

### A New Pathway to Islamic Education in Indonesia

he International Open University (IOU) has always been dedicated to offering genuine Islamic education with a focus on student convenience. ### A Two-Day Hybrid Research Conference

he IOUCRIS (International Open University Conference on Research and Integrated Sciences) is a hybrid conference designed as a forum for researchers, academics, and practitioners worldwide to discuss and exchange ideas on contemporary research issues in integrated sciences.

The IOU held a two-day hybrid conference on Research and Integrated Sciences on October 24th, 2023. The in-person segment of the conference took place at the Kairaba Beach Hotel in The Gambia, followed by a virtual continuation via Zoom on October 25th.

Over 100 papers were presented at the conference, covering topics such as Arabic Language and Literature, Islamic Economics, Business Administration, Education, Psychology, and Islamic Studies. Notably, the conference featured over 20 papers written in Bahasa.

The third event of the International Open University Conference on Research and Integrated Sciences (IOUCRIS) was organized by IOU and the Open University of Malaysia (OUM) in Malaysia on February 23rd, 2023.

### Examining the Assertion that the "Hijāb" Sexualizes Children and the **Experience of Muslim Girls Wearing** Hijab in 21st Century UK

### Abstract

This research seeks to examine assertions by Amanda Spielman, UK chief school inspector, that expectations on young girls to wear a Hijāb (Islamic headscarf) sexualizes them. Spielman issued a new policy of interrogating prepubescent schoolchildren about Hijāb in November 2017. The research further explored the impact of Hijāb on the lived experiences of girls in the UK. Spielman's interviews, speeches, reports, along with contemporaneous events, global conflicts, and government policies were examined for context. Simultaneously, Islamic scriptures (Our'an), traditions of Prophet Muhammad topic were and scholarly exegesis on the topic were reviewed. Census data, conception data and government data on the sexualization of schoolgirls were also analyzed for trends related to Hijāb. The study found little evidence to support Spielman's assertions on sexualization by Hijāb. Islamic scripture was found to consistently oppose and mitigate the sexualization and abuse of girls.

New primary data was obtained through 150 survey interviews, predominantly of Hijābwearing women, on their experience of Hijāb and sexualization. Rather, trends of reduced sexualization, and increased Islamophobia were significantly observed in participant testimonies. Contemporary literature further traced sexualized imagery of the Hijāb to orientalist war propaganda, feminism, and colonialist portrayals of Muslims. Data on the sexualization of girls in the West and underage conception rate data for the UK indicated that Muslim girls suffered less sexualization than others.

This research aims to critically examine policies targeting Muslims in UK schools. It also establishes a replicable survey that can give voice to Hijāb-wearing women and track the consistency of these findings or any changing trends over time and geography.

### **Body Outline-Emotion as Emotional** Management Tool for Children and Adolescents: A Therapist's Perspective

### Abstract

Today's children and adolescents experience various pressures, leading to an increase in mental health problems, not only in Malaysia but throughout the world. Methods of managing stress and emotions are divided into positive and negative methods. Note that applying positive methods is important so that this group remains safe and healthy.

This qualitative study utilizes a grounded theory approach to explore the emotional



management strategies used by children and adolescents from a mental health therapist's perspective. Eighteen mental health therapists were interviewed using semi-structured interviews for twenty cases of children and adolescents who experience mental health issues. Therapists use the body outlineemotion tool, namely "Creative Expressive-Bodily Maps of Emotions (CE-BME)", in psychotherapy sessions. Consequently, the grounded theory analysis establishes a framework for using CE-BME to identify and reshape emotional management strategies for children and adolescents who experience mental health issues.

These findings have implications for therapists using CE-BME tools for emotional management as positive coping skills. CE-BME can be a guick and effective tool in helping the young group in intervention. It can assist in psychoeducational settings and in preventing mental health issues from deteriorating further.

# Cultivating the Guardians of the Qur'an

### **GQMC's 10 Year Milestone**

he tradition of preserving the Qur'an in the hearts and minds of Muslims began during the time of Prophet Muhammad , who emphasized its significance and extolled its virtues. The companions of the Prophet understood the critical importance of preserving this sacred text. Their concern was heightened when many huffadh (guardians of the Qur'an) perished in the battle of Yamama, raising fears about the potential loss of the Qur'an.

To continue this legacy of preservation, the International Open University (IOU) initiated its journey of online Qur'an memorization by launching the Global Qur'an Memorization Center (GQMC) in the summer of 2013.

The program begins with Tajweed Easy Starters for beginners, offering foundational steps in learning Arabic letter enunciation – ideal for those struggling with sounds like 'haa' (ح and ه).

For more advanced students, the Tajweed Intensive course is ideal; it comprises over 22 modules and two weeks of intensive practice classes, focusing on enhancing recitation skills. This course inspires students to emulate renowned reciters like Mishary Alafasy, always for the sake of Allah.

GQMC's group memorization program offers a modern approach to Qur'an memorization, fostering a supportive environment where aspiring huffadh can inspire one another.

Additionally, it offers diverse learning pathways, such as the One Ayah A Day and the One-on-One Qur'an program. The One Ayah a Day program is best suited for those preferring a steady pace, focusing on daily memorization of a single Qur'anic verse with the goal of eventually mastering all 6,236 verses. Alternatively, the One-on-One

program caters to students seeking personalized attention.

All programs are accessible from home, led by certified huffadh, accommodating various time zones. The fee structure is thoughtfully devised based on each country's human development index, ensuring affordability worldwide. Furthermore, study groups are gender-segregated, led by qualified male and female teachers – a testament to the platform's comprehensive approach to Qur'an memorization.

For those aspiring to teach the Qur'an and impart lasting knowledge, the prestigious Ijaazah program is an excellent choice. Under the guidance of experienced huffadh, Ijaazah students receive one-on-one supervision, culminating in an Ijaazah (license to teach), and a certificate to educate future students of the Qur'an.

With 357 licensed huffadh and 48 ljaazah recipients, the GQMC has demonstrated that remarkable achievements are possible, through ten years of dedication and Allah's grace.

So far, more than 2,800 students have enrolled to become guardians of the Qur'an, and GQMC looks forward to welcoming many more. After all, the most esteemed among us are those who learn and teach the Qur'an.
